

**Targeted Assessment for Prevention (TAP):**

A quality improvement framework that maximizes resources to more efficiently reduce healthcare-associated infections (HAIs).

Prevent HAIs by:

- Targeting locations with excess infections
- Assessing for gaps
- Implementing interventions

NHSN\* reports use data to identify facilities and units with excess infections and target efforts to most efficiently reach prevention goals.

**Assess**

Assessments—like the CAUTI Tracer and audit tools—systematically identify opportunities for improvement while serving as real time education and training resources.

CAUTIs result in thousands of deaths each year and billions of dollars in added costs to the U.S. healthcare system, yet these infections are preventable.
