Steps in Performing CLIA Waived Antigen Tests

Steps	Who Can Perform Step?
Conduct nasopharyngeal (NP) or oropharyngeal (OP) or anterior nasal swab.	 Most licensed professionals Medical assistants can perform anterior nasal swabbing only (CNAs, home health aides cannot)
Observe self swabbing	Any Trained Individual
Add reagent to test	Any Trained Individual
Read, interpret, report test results	Any Trained Individual

Over the Counter Tests vs. Professional CLIA waived Test

OTC Home Test Kits	Professional CLIA waived test kits
Most kits contain 2 tests	BinaxNOW contains 40 tests per box
Individual dropper with reagent fluid for each test	1 single bottle with reagent fluid for 40 tests
No performance of control by user required	Requires performance of controls under direction of CLIA lab director
CLIA waiver is NOT required	CLIA waiver and lab director REQUIRED
 Self-Test is Allowed. Comply with SPHO: Visitor testing must be observed. In order to ensure these tests remain as OTC, and not fall under CLIA regulatory requirements, the entire test needs to be performed and read by the individual being tested. It is acceptable to have an observer watch the individual perform the test and verify the result, however the individual performing the test must read their own result first before verifying their result with the observer. 	 Self-Test Not Allowed, Visitors cannot test themselves. CLIA waived tests cannot be used as OTC tests. Comply with SPHO using a CLIA waived test: Visitor self-swabs under observation and facility staff performs test.
 Reporting to NHSN/CalREDIE: Reporting is NOT required if individual performs self-tests entirely by themselves (Individual should report positive results to their PCP). 	Reporting to NHSN/CalREDIE: All results need to be reported (negative, positive, indeterminate).
