

HSAG Facility Assessment Tool



Facility Assessment Tool

Requirement

The facility must conduct and document a facility-wide assessment to determine what resources are necessary for its residents competently during both day-to-day operations (including nights and weekends) and emergencies. The facility must review and update that assessment, as necessary, and at least annually. The facility must also review and update this assessment whenever there is, or the facility plans for, any change that requires a substantial modification to any part of this assessment (§483.71).

The regulatory requirement for the Facility Assessment is found in Attachment 1.

Purpose

Use this assessment to make decisions about the facility's direct care staff member needs and their care provide services to the residents in the facility. Using evidence-based, data-driven methods and a common based approach focuses on ensuring that each resident is provided care that allows the resident to maintain his or her highest practicable physical, mental, and psychosocial well-being. The Facility Assessment is the foundation for the facility to assess its resident population and determine the direct care staffing and resources to provide the required care to their residents.

The intent of the Facility Assessment is for the facility to evaluate its resident population and identify resources needed to provide the necessary person-centered care and services the residents require. assessment helps ensure that facilities have an efficient process for consistently assessing and meet necessary resources and staff that the facility requires to provide ongoing care for its population to the specific needs of its residents.

Overview of the Assessment Tool

This is an optional tool provided for nursing facilities and, if used, it may be modified. Each facility has the flexibility to decide the best way to comply with this requirement to ensure the needs of its unique population are met.

The tool is organized in three parts:

1. Resident population including:

- The number of residents and the facility's capacity.
- The care required by the resident population using evidence-based, data-driven methods, types of diseases and conditions, physical and behavioral health needs, cognitive disability, and other pertinent facts that are present within that population consistent with individual resident assessments.
- Staff competencies and skill sets necessary to provide the level and types of care needed for this population.
- The physical environment, equipment, services, and other physical plant considerations to care for this population.
- Any ethnic, cultural, or religious factors that may potentially affect the care provided, but not limited to, activities and food and nutrition services.

2. Facility's resources including:

- All buildings and/or other physical structures and vehicles.
- Equipment (medical and non-medical).
- Services provided, such as physical therapy, pharmacy, and specific rehabilitative services.

1. The Facility's Resident Population

Numbers

- Indicate the number of residents the facility is licensed to care for (enter number of beds). Recommend differentiating between long-stay and short-stay residents or other categories (e.g., unit floors or specialty areas or units, such as those that provide care and support for persons with dementia or using ventilators).
- Indicate the facility's average daily census (enter a range). Recommend differentiating between long-stay and short-stay residents or other categories (e.g., unit floors or specialty areas or units, such as those that provide care and support for persons with dementia or using ventilators). Consider if it would be helpful to describe the number of persons admitted and discharged, including high peak times or shifts for admissions and discharges, as these processes can impact staffing needs. Use evidence-based, data-driven methods to capture the information needed.
- Indicate the facility's demographics of its residents, including age range, gender, and race.



Vaccine Ambassador Program: On-site Clinic and Education Support

No-Cost Vaccination Clinics

- HSAG is coordinating **no-cost vaccination clinics for all staff members and residents**, regardless of insurance coverage.
- Minimum requirement is 20 vaccinations of any combination of COVID-19/pneumonia/influenza (in the fall).
 - Can include any combination of staff members and resident vaccinations.



Vaccine Education Support



HSAGs vaccine ambassadors can provide customized technical assistance, including:

- Reviewing current vaccination rates.
- Determining challenges/barriers to increased uptake.
- **Scheduling on-site or virtual education support based on facilities' needs/requests.**
- Coordinating with the vaccination clinic scheduling team to provide on-site vaccination assistance for staff members and residents.


