
NHSN Updates



Annual Influenza Report

NHSN Annual Influenza Report is due by May 15, 2024.

- This report must be completed in the Healthcare Personnel Safety (HPS) component.
- The HPS component needs to be added only once, but reporting must be done every year.
- Guidance for how to add the component and complete the reporting can be found in Appendix B of the <u>HSAG Survival Guide for Mandatory NHSN Reporting for LTCFs</u>.




COVID-19 Updates

Receiving the latest updated COVID-19 vaccine is the best way to protect






California COVID-19 Resident Vaccine Rates (Data for week ending November 5)






Percentage of CA NH Residents who are Up to Date with COVID-19 Vaccines






California COVID-19 Staff Vaccine Rates (Data for week ending November 5)






Percentage of CA NH Staff who are Up to Date with COVID-19 Vaccines

Access and Cost Barriers

- Pharmacy is not stocking the vaccine
- Pharmacy has a minimum vaccine requirement for clinics
- Lack of time to research alternative pharmacy options
- Cost of vaccine for under or uninsured staff
- Upfront cost of vaccine




Holiday and Winter Surge
