



How to Find the Chat Button


- Scroll your mouse on the screen to see the menu at the bottom of the slide.






Run Chart





Donning and Doffing PPE Video

- CDC video: gowns, masks, and other PPE look different from what the nursing home was using
- Created their own video:
 - In their own surroundings
 - Using their own PPE
 - Demonstrated by their own staff members





IP Compliance Engagement Incentive

- Fun way to make sure staff are compliant with IP strategies
- Created IP cash
- Get a dollar/lose a dollar





Doff-icer Program

- IP is everyone's responsibility, not just IP staff
- Designate a "doff-icer"
- "All hands on deck"
