CDPH Updates

Requests for Urgent Staffing Resources for COVID-19 CDPH AFL 20-46.3

- Per the AFL, nursing homes are urged to report staffing needs to local health departments and the Medical Health Operational Area Coordinator (MHOAC) to initiate the process of locating staffing resources from healthcare facilities, coalitions, medical reserve corps, local staffing agencies, etc. <u>https://www.cdph.ca.gov/Programs/CHCQ/LCP/Pages/AFL-20-46.aspx</u>
- If the MHOAC cannot fulfill staffing needs, staffing resources will be requested from the region via the Regional Disaster Medical Health Coordinator (RDMHC).
- If regional resources are inadequate, the RDMHS will forward the request to the Medical Health Coordination Center (MHCC).

Strategies to Reduce Risk: Humidifier Guidance

Q: Recommendations about using a humidifier in a shared SNF resident room?

A: Humidifiers are not ventilation devices. High humidity may affect the function of portable air cleaner (PACs), if a facility is using them in close proximity to the PAC. However, studies have shown that maintaining 40-60% relative humidity rates in healthcare reduce both respiratory and gastrointestinal infection rates. https://www.ashrae.org/file%20library/technical%20resources/covid-19/56-1.pdf

Strategies to Reduce Risk

- Humidifiers can be an issue in and of themselves if they are not cleaned and disinfected regularly.
- Remember that water from the tap is not sterile, and even sterile water can become contaminated with the settling of airborne dust or application into a non-sterile device.
- Legionella is a concern since humidifiers are emitting fine water droplets into the air that can be inhaled.
- The rooms you are deploying these devices may have immunocompromised people, so humidifier preventative maintenance is critical and should be policy/procedure driven and not left to chance.
