Introducing Project Firstline

- CDC's National Training Collaborative for Healthcare Infection Prevention and Control
- Committed to preparing frontline healthcare workers to protect themselves, their patients, and their communities from infectious disease threats through education and training in infection prevention





Project Firstline in California

- Aims to reduce healthcare-associated infections (HAI) in SNF
- Build a universal understanding of the rationale for infection prevention practices
- Develop competency in performing infection prevention practices
- Promote resident and healthcare worker safety





Certified Nursing Assistants (CNA) are an Integral Part of Resident Care

- Public health infection prevention and control (IPC) support is critical for outbreak prevention and containment in SNF at high risk for COVID-19 outbreaks, where facility-level IPC capacity is frequently limited
- The HAI Program will engage CNA in an interactive and supportive training environment, empowering them to understand the why, and not just the how, of carrying out infection prevention practices.
- All California SNF are invited to participate

Tailoring Training Sessions to Meet the Needs of California CNA

- Learning Needs Assessment open now through June 18, 2021

- All SNF staff are invited to participate. Participation is optional and not required to participate in the educational training sessions





Interactive Training Sessions

- Monthly sessions launching Summer 2021
- Each training session will highlight common tasks performed by CNA in the skilled nursing facility setting as it relates to specific infection prevention practices.
- Each course will be offered multiple times to accommodate CNA schedules, and will be an opportunity for peer-to-peer learning.
- Trainings will be virtual and interactive.
